Bull Run Acclamation Pond

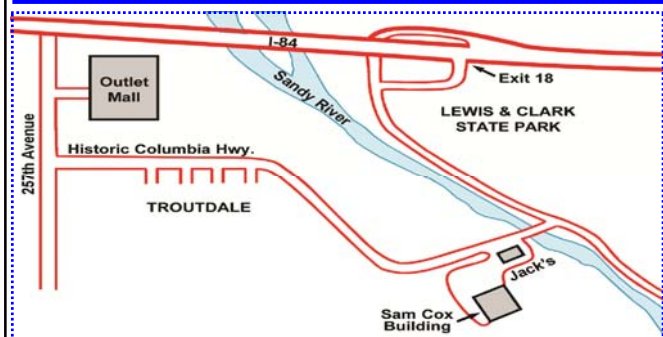
Sandy River Steelhead members:

Jeff Fulop from the ODFW has asked for our help in with feeding Spring Chinook Smolts at the Bull Run acclamation pond. The first group of 66,000 is scheduled to arrive February 27th pending the result of a lawsuit by The Native Fish Society and the McKenzie Fly fishermen. Around March 19th we should receive another 66,000 Smolts. I can't say enough about how our members hung in there through all the legal uncertainty of last year. This lawsuit has at least brought the Sportsman, Commercial Fishermen and Indians together on one side to fight to keep the hatcheries open. The Sandy River Steelheaders are a major participant in this fight and we are going to show The Native Fish Society and the McKenzie Fly fishermen that we will not be intimidated by their lawsuit. For those of you who are unfamiliar with feeding Spring Chinook Smolts at the Bull Run acclamation pond; for 19 days we go out to the old abandoned Power Station on the Bull Run River (North of Sandy) and feed the fish with pellets once or twice a day. When we are out there we check to see how the fish are doing and if any fish are dead we write down the number. We will have an orientation meeting for the volunteers before the fish arrive.

It's kind of an interesting place, the TV program Grimm was shot there. If you just want to volunteer for one day that is fine. Should litigation get in the way of the planting, the ODFW will keep us updated.

"EGGS TO FRY"

Have you ever heard someone mention or, have you ever read something about "Eggs to Fry"? Well, "Eggs to Fry" has nothing to do with hash browns, bacon and toast, in fact it is sometimes referred to as a hatch tank operation. This program is coordinated through the Oregon Department of Fish and Wildlife's (ODFW) Salmon-Trout Enhancement Program (STEP). This fish egg incubation project is a popular and valuable classroom education tool and is facilitated through regional STEP biologists. Teachers apply to their local STEP biologist for inclusion in the program and then the teacher applies for grants or donations in order to receive the equipment necessary for incubating the eggs.

After successfully being accepted into the program, the classrooms receive eggs, free of charge, from ODFW. There is a distribution of Rainbow Trout eggs in early February and Chinook Salmon eggs in October of each year. The eggs are placed in an aquarium equipped with gravel on the bottom, a water pump-filter for circulation, an aerator for oxygen supply and a small refrigeration unit, called a chiller, to maintain the desired water temperature. Students are assigned to monitor the temperature, the pH level and the condition of the eggs and the fry after they hatch, each day and record the data. The fry are not fed in the tank, as they are nourished by the yolk sack on their belly. The eggs are distributed to the schools when they are about 20 days old and stay in the tank after hatching until they have absorbed the yolk sack. The time from arriving at the classroom to the time the fry will be ready for release depends on the species and the temperature of the water at the hatchery. Trout will arrive at the fry stage about 52 days after the eggs are received and Chinook somewhat longer. When the fry are ready for release, the trout go into designated lakes or ponds and the salmon go to designated streams or rivers. The students that participate in this program have a full curriculum, learning about the life cycle of fish, science, math, English, social studies and career related subjects.

The Association of Northwest Steelheaders has approximately 75-80 schools who have been involved in this program, with Sandy River, McLoughlin, Tualatin Valley and Emerald Empire chapters participating. On February 5, Sandy River delivered eggs to 6 schools, McLoughlin delivered to 6 schools and TV delivered to 22.

Anchoring your drift boat - with logs in the river...

OK, so the title may be a little mis-leading. Frankly, if there are logs in the river that you need to be wary of - you shouldn't be in your drift boat on the river (in my opinion - I wouldn't be!) and you should consider another day.

While doing some research on anchoring drift boats, I found that the main reason for a boat going down is - the anchor. You would think that boats get sunk because they hit big rocks or the pilot choose the wrong route through the rapid. But actually a lot of boats go down because something goes wrong with the anchor - according to a boat salvage recovery expert. You should **always** be sure to stow your anchor properly before heading down river. Do not tie a knot in your anchor rope, when the anchor is swinging behind the boat, bumping through the rapids it can jar loose from the cleats. The anchor drops in and shoots through the pulley, and if there is a knot at the end of the rope, the anchor rope comes tight and that boat sucks right down to the bottom.

Put your anchor inside your boat, that is why there are little pockets in drift boats.

Be safe and smart, not sunk.

The Frostbite Follies - did you know?

The Frostbite Follies was named after Ray Hinea, long time Steelheader & avid fisherman. The Follies is a drift boat trip from Oxbow Park to Dabney Park on the Sandy River, weather and river conditions permitting. This is not for the faint of heart, weather wise. Frozen guides, fingers and ears are not uncommon, dress accordingly. Last year, during ideal weather conditions forty-two hearty souls piled into fourteen drift boats and made the trek, a few fish were hooked and landed. Dan Drazan clearly had the hooked part down, but failed to show his sons, Christian & Isaac, the 'landed' part. Anglers area always ready for a warm fire and a hot lunch at Camp Angelos, about 2/3 of the float. This year's chef de jur is Robert Wisher, a retired pastry Chef.

The Follies are slated for March 22nd, the event was postponed in February due to unsafe weather and water conditions.
