The basic duties of officers and directors of the Sandy River Chapter are as follows:

Way back in another time early in my career as a research forester with the U.S. Department of Agriculture, Forest Service, Pacific Northwest Research Station I was held captive at a motivational speech given by an ex-convict – someone who paid their penance and then found their calling. The talk's theme was people begin to stray down the wrong path because 'they get use to" the transgressions of doing so. I was just in this state – stuck to my comfortable recliner focused on the weekend sports TV menu -- when I missed a call from my fishing buddy – let's call them Larry (because that is

their name). Heroically, Larry was kind of enough to leave me a message about wanting to going fishing. Like a bull in a china shop, my world of laziness and thinking about responsibilities came crashing down around me and wouldn't you know it I was checking the forecast, river levels and the like so as to be prepared to plan our trip when I returned the call. Just like that fishing was the priority for the weekend. A call to action.

There are two kinds of people in this world – those that are fishing buddies and those that desperately need them. Larry and I rendezvoused at a popular bank spot and enjoyed the morning "fishing" – which you would think would involve a line in the water with a lure or bait at the end. We did that, but we also sat by the river enjoying hot green tea and sharing a ham, bacon, avocado and Swiss sandwich. We passed the time talking about nothing and made enough casts I guess to keep our spot. Not a tug was to be had. But the spell had been broken. I left with the feeling I needed to get out fishing again. It was something I definitely could get use too, and thanks to fishing buddies, will.


