President's Message

The NW Hatchery Programs are Under Attack

The recent refusal by US District Court Judge Ancer Haggerty to grant an injunction stopping all releases of hatchery Fish into the Sandy River and all of its tributaries was a victory for the ANWS, and it allies, who filed an amicus curiae (friend of the court) legal brief in support of ODF&W.

While this ruling is a victory for the ANWS, it is only a victory in the Sandy River battle against the NFS, but it is by no means the end of the overall regional war being waged against hatcheries. At issue is the Hatchery Genetic Management Plans (HGM) filed for all rivers with hatcheries but for the Sandy River in this case. There are and have been other cases trying to

overturn the entire hatchery program in the region.

Two suits were filed in CA, one on the Elwa River in WA and one on the McKenzie River in OR, in addition to the Sandy River filing.

The Sandy River Chapter of ANWS is actively helping defray the costs of the Sandy River suit by helping fund the amicus, by pledging further financial support and by sponsoring the Sandy River Spring Chinook Classic.

You can help by supporting ANWS financially and by participating in the June 1st Spring Classic, whose net proceeds are pledged to the defense fund.

The Sandy River Chapter challenges the other ANWS Chapters to match us 'in kind' in defense of our rivers.


Today it is the Sandy and Elwa Rivers, tomorrow the McKenzie and later your river.



Meeting called to order by Doug Briggs at 6:30 p.m.

Meeting minutes from prior meeting were approved.

I. Old Business

- 1. Doug reported that the Sandy River Classic entry fee is \$60, not \$50 as previously reported.

- 14. John put out the request for content for the website.







PFD, to Swim or to Drown

Fishing buoy 10 out of Hammond, we were tied up at the dock by 2:30 because gale force winds were forecast for 3:30.

We were hoisting a beer, cleaning fish and listening to the Coast Guard Channel, when the Coast Guard reported two capsized boats and 6 men in the water.

Later that evening, on the 11:00 news an overzealous TV reporter accusatorily asked the young Coast Guard Lieutenant "What went wrong here today?". Unfazed by her demeanor, he responded with something like: it's actually quite simple, two boats capsized putting 6 men in the water, three were wearing life jackets, three were not. Guess who drown?

We lost an 18 year old, a 54 year old and a 68 year old, all men.

This cold water doesn't care how old or how macho you are. It kills quickly.

At a meeting last month I ran into a friend with his two middle fingers taped together. I ask what happened to his fingers. He said he dislocated them when his son threw them both out of his Kauffler boat into the cold Willamette. He had just re-motored the boat, which continued down the river until it hit the I-5 bridge, destroying itself. He said they had PFD's on or they would be dead.

Are you worth \$150? Can't you pass up a couple of Kwik Fish & service your PFD Annually?

Bull Run Acclimation Pond

I want to thank the 11 Sandy Chapter people and 3 community volunteers who worked with Jeff Fulop from the ODFW to assist with feeding Spring Chinook Smolts at the Bull Run acclimation pond.

The first group of 66,000 arrived March 1. They were scheduled to be released March 22nd, but a lawsuit by the Native Fish Society and the McKenzie Fly fishermen held up the release date for an extra week.

This resulted in a higher daily mortality rate for the Smolts. On March 28th we received another 66,000 Smolts.

I can't say enough about this crew, they really hung in there through all the legal uncertainty.

I hope in 2 or 3 years to see these fish again.

The volunteer's put in a total of 176 hours and traveled 1,724 miles.
