President's Message

The Battle For Oregon's Rivers is Not Over

Though-out history there are numerous occasions where the battle was won, but ultimately the war was lost. Lost because the opponent was underestimated, the battle winner was lulled to sleep by the win or the enemy redoubled its effort.

In the battle for Oregon's rivers ODF&W's opponent, who is also our opponent, has a huge war chest, can and will work the legal system to divert resources away from needed activities and drive the legal cost up. Delaying tactics, frivolous motions and appeals all work to their advantage, because they deplete our resources and delay the process.

The recent Judges denial of the injunction to stop discharging hatchery fish into the Sandy was a big win in terms of battles. It was also a clever ruse to destroy the current hatchery runs of Summer, & Winter Steelhead and Spring Chinook Salmon.

By manipulating the legal system with continuances, motions, appeals and other delaying tactics, they could have stop hatchery production of Sandy River hatchery runs for three or four years, just long enough for those runs to become extinct. In those three or four years of legal maneuvering the existing gene pools are lost forever.

Despite our current lack of an adequate war chest, we have started the process of building one.

The Sandy River Chapter did due diligence in standing with the Association, committing and delivering funds for the *Amicus Curiea* brief and pledging future funding for the Defense Team.

The Association took a further step in pledging the net proceeds from the Sandy River Chinook Classic to the Sandy River Defense Fund.

We know the 'Pen is Mightier than the Sword'. Now is the time to prove it.

Mustard Roasted Salmon

Ingredients

Members only - In Stream Fish-along

- 1 1/4 pound wild salmon, skin removed, cut into 4 pieces
- 2 tablespoons whole grain mustard
- 2 tablespoons 100% pure maple syrup
- 1 clove garlic, minced

Juice of 1/2 a lemon

Directions

Preheat oven to 400-degrees Fahrenheit. Place salmon pieces on a sheet pan lined with parchment paper. Season with salt and pepper; roast for 10 minutes.

In a small bowl, combine mustard, maple syrup, garlic and lemon juice. After the 10 minutes of cooking, brush salmon with mixture and return to the oven for 5 minutes or until salmon is just cooked through.


The volunteers put in a total of 71 hours and commuted for 87 miles.

Naughty Knots

Doug Briggs

As anglers, we learn some basic knots to connect line to line or line to hardware and we perfect them over time until we tie them without think about the properties of the knot.

As boater we develop our repertoire of favorite knots. These knots are often handed down from generation to generations with little thought about the knot's properties.

Knots have a number of properties that make a type of knot better than another. These include the ease of tying, the tendency to cinch tighter, releasing under a load and finally the ability to untie it. My absolute favorite knot is a bowline, easy to tie (snake come out of the hole, goes around the tree and goes back in the hole), won't cinch and you can untie it or use it as a slip knot (a running

I was crushed to learn that my absolute favorite knot in the whole world was flawed. Its principal short coming is that you cannot untie it under a load. You can tie it around your waist and it will not cinch, but you have trouble getting it to release if it is carrying a load.

There are two ways to discover that potentially dangerous fact, on the water with a strain on a line that will not release or in a book (today on the internet). I stumbled, quite by accident, onto a website called www.animatedknots.com and read about this shortcoming.

I don't want to teach you new knots or demonstrate shortcuts to faster knot tying for your knots. What I will do is encourage you to spend a few minutes on the website reviewing your favorite knot and it properties, both naughty & nice.




