

#### **Steelhead Clinics**

The chapter put on two clinics this last weekend. Ed Fast volunteered his services and he put on a excellent clinic at sportsman's warehouse. Ed thought more advertisement would've helped out in the turn out department. Ed said that his clinic was more informative about fish being released and broodstock planting on various northwest rivers. The individuals who attend the clinic were very pleased because it was more than just talking about jig fishing with bobbers or drift fishing with eggs and yarn. Ed talked about how to get the information to narrow your trip down to make it a productive trip and not a waist of time. He told the group that you can contact your hatcheries to see when the fish are showing up at the hatchery, and were they plant the fish on the rivers, and what time of the year they do this. Ed also mentions that you should log all your info, so you can use it in the future. Sportsman's was very pleased with how it went and how very informative it was. They would like to have more clinics in the future and help support our chapters efforts. We also put on a clinic at Joe's in Gresham. #### Take Action, Win a Gift

Frustration with the management of Columbia River fisheries is growing to a crescendo. Members of the NW Steelheaders are writing emails and letters to their state legislators to express their anger. Our lobbyist, Phil Donovan, has confirmed some numbers of correspondence while talking these legislators in the Capitol. Yet, without a copy of your email or letter, we have no idea what our members' communications actually said, making it impossible to bolster your efforts with reinforcing follow-up. In other words, the NW Steelheaders would be much more effective if we had copies of your e-mail or letters to your legislators.

All Sports Supply (distributors of sport fishing products) has offered to help the Steelheaders motivate its membership, facilitate necessary tracking of letters to legislators, and get more people to attend their chapter meetings.

Here is how it will work. E-mail or mail us a copy of your letter to your state legislators, and we will have a great 'Thank You' gift at your chapter meeting. (The gifts are being provided specifically for letters addressing the issue of selective commercial harvest addressed to state legislators - not Federal legislators - at this time.)

So please write your state representative and senator today. If you don't tell them there is a problem, they won't know one exists. Together we can make a difference with a well-thought out campaign to influence decision-makers about an issue that is making you (and lots of others) very mad.

To find out who your legislator is go to http://www.leg.state.or.us/findlegsltr/findset.htm It is important that you use your own words, stay on message and stay polite.

Explain your concerns with non-selective commercial harvest and by-catch mortality. Let them know that ODFW can do a better job of managing fisheries.

Write or call back if you don't hear from them after a week. Let them know that you need their voice to solve this problem. If they have any ques-

tions, feel free to refer them to Phil Donovan (phil@nwpublicaffairs.com).

Share your e-mail/letter and forward it to your fishing friends and family. We are all very frustrated and the only way change is going to occur is if we can push this issue over the tipping point.

#### A Sample Letter

Sandy River Chapter



State Representative/Senator, My name is \_\_\_\_\_. I live in your district at (street and address).

I am writing to you because the Oregon Fish & Wildlife Commission and staff at the Oregon Dept. of Fish & Wildlife tell me they are managing Columbia River fisheries according to the intent of the Oregon Legislature. As you know, salmon and steelhead fisheries have been crippled with closures and sport anglers are contributing both time and money to save fish. NW Steelhead chapters are working to improve habitat and our license dollars fund the mission of the Oregon Dept of Fish & Wildlife.

Yet ODFW continues to manage the Columbia River like 100 years ago:

- ODFW allows gill-net fisheries in the Columbia River that indiscriminately catch whatever swims into them.
- ODFW allows gill-net fisheries in the Columbia River to harvest endangered fish before the run size is known.
- ODFW allows gill-net fisheries in the Columbia River when water temperatures are high which kills wild fish that are supposed to be released.
- ODFW allows gill-net fisheries in the Columbia River when every other state, except Alaska, has eliminated gillnet fishing.

NW Steelheaders support commercial fishing. But we insist that those commercial fisheries fish selectively so we can restore wild runs to healthy, sustainable numbers. If ODFW insists on gill-net fishing, then we should put them in areas that do not have endangered wild salmon and steelhead.
